iiSBE is an international non-profit organization whose overall aim is to actively facilitate and promote the adoption of policies, methods and tools to accelerate the movement towards a global sustainable built environment. iiSBE has an international Board of Directors from almost every continent and has a small Secretariat located in Ottawa, Canada. We have 196 members in 31 countries with active Chapters in Austria, Czechia, Italy, Portugal, and Taiwan.

Our specific objectives include the following:

- Map current activities and establish a forum for information exchange on SBE initiatives, so that gaps and overlaps may be reduced and common standards established;
- Increase awareness of existing SBE initiatives and issues amongst the international buildings and construction community;

During the 1990's he developed the Canadian national C-2000 demonstration program for high-performance buildings. The program led to the first public adoption of the integrated design process (IDP). NL was principal developer of SBTool, a system for assessing the sustainability performance of buildings used as an R&D platform in many universities, and was co-developer of SNTool, for assessment of neighbourhood environmental performance. NL represents four international partners (CIB, iiSBE, FIDIC and UN Environment) in managing the SBE international series of conferences on sustainable built environment. He was a founding member of iiSBE in 2001 and is a Fellow of the Royal Architectural Institute of Canada.
